**GENERAL STATEMENT OF FUNCTION:** The incumbent for this position will provide the implementation, configuration, maintenance, and support of a centralized network, supporting the LAN, WAN, Microsoft Active Directory, and the underlying server and desktop infrastructure. Helpdesk support for network, server, and desktop-related issues will also be a part of the day-to-day activities for this position.

## RESPONSIBILITIES:

- User and Group Administration, including password, access management and GPO's.
- Building and supporting Windows and Linux servers in a VMware environment;
- Managing Network infrastructure, including switching and routing.
- Patch Management and application installation.
- Administering and supporting remote access technologies (SSL VPNs).
- Administering nightly server backups.
- Protect data integrity with antivirus and backup software.
- Maintaining infrastructure & related systems such as VMware VCenter
- Providing desktop and software development.
- Providing phone support for end users, documenting incidents in the IT tracking system.
- Providing staff training.
- Researches available tools and technologies to determine alternative technology solutions.
