Your 2024 Summer Award (if any) will be based on your eligibility and attendance for the 2023-2024 Academic Year. You must complete a 2023-2024 Free Application for Federal Student Aid (FAFSA) if you have not already done so.

ALL STUDENTS MUST BE REGISTERED for summer classes prior to submitting this form. We will determine your summer eligibility for financial assistance based on your registered, program eligible credits. **We will not determine an award unless you are registered for summer classes.** If you change the number of credit hours you are enrolled in, please contact our office as your eligibility may change.

- **Pell:** If you were awarded the Federal Pell Grant for the 2023-2024 Academic Year, you **may** have Federal Pell Grant funds remaining to use for the Summer Semester tuition.
- **Loans:** FIRST TIME borrowers will have to wait thirty (30) days from the beginning of the semester before their loan will be disbursed. Financial aid funds are disbursed in equal installments at the first of each semester. If a student is only attending the Summer semester, disbursement of loans will be made in two (2) equal disbursements, one (1) at the beginning of the semester and one-half way (1/2) through the semester. Eligibility for student loans will be determined by the Financial Aid Office. If you have not received the maximum loan amounts of your annual limits during the 2023-2024 Award Year, then you may be eligible for a summer student loan. Students can only be awarded student loans up to the annual loan amounts allowable.
