



The American Rescue Plan Act (ARP) Higher Education Emergency Relief Fund III (HEERF III) provides emergency funding to institutions of higher education to assist students in need during the coronavirus pandemic. The College of Eastern Idaho has signed and returned to the Department of Education, the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received from the ARP Act to provide Emergency Financial Aid Grants to students.

CEI has received \$ **1,910,651** in APR Act funding to distribute to students.

As of **September 30, 2021**, CEI has distributed \$0 of the Emergency Financial aid Grants to students.

All enrolled eligible, include: exclusively enrolled in distance education. Prioritize students with exceptional need, use FASFA and EFC to determine need.

Eligible: Non-Degree Eligible, DACA, Undocumented- Fall into NO FAFSA pool.

Exclude: Dual Enrolled, Early college, Employees with waivers. Non-Degree? Supplemental Application

CEI will prioritize assistance to students with the greatest financial need. Students will be identified through enrollment and the 2021-2022 Free Application for Federal Student Aid (FAFSA). Funds will be automatically offered to students who met the following criteria: Enrolled undergraduate degree-seeking, students for the Fall 2021, as of the date/time of the grant distribution. Eligible U.S Citizen or eligible non-citizen as determined by the 2021-2022 FAFSA. An official Expected Family Contribution (EFC), will be used in determine need and awarding criteria. Students that are registered that did not complete the FAFSA, or submit all required documents, non-degree seeking will receive only a minimal payment.

CEI will use the estimated remainder of the allocation of the ARP HEREFF III Grant to assist students for the Fall 2021 term and Spring 2022 until funds are exhausted.

Components- COA, emergency cost due to COVID. Tuition, food, housing, health care
