Financial aid funds are disbursed in equal installments at the first of each semester. If a student is only attending the Summer semester, disbursement of loans will be made in two (2) equal disbursements, one (1) at the beginning of the semester and one-half way (1/2) through the semester. Eligibility for student loans will be determined by the Financial Aid Office. If you have not received the maximum loan amounts of your annual limits during the2023-2024 Award Year, then you may be eligible for a summer student loan. Students can only be awarded student loans up to the annual loan amounts allowable.
