Deadline: To submit a Marital Status Appeal the Fall term deadline is September 1st. Student(s) that did not attend the Fall Term or appeals submitted after September 1st will be held and applied to the Spring term. Marital Status Appeals for Spring term must be submitted by February 1st. After February 1st the student must wait until the next award year to change marital status. All documentation must be provided. If documentation is not supplied the appeal will not be reviewed. **Note:** Marital status changes do not always increase Financial Aid eligibility. The Financial Aid Office will only process an appeal if the appeal is beneficial to the student.

This appeal should only be submitted by a student whose marital status has changed since filing the FAFSA.
